2.6.1 Program outcomes, program specific outcomes and course outcomes for all programs

- Offered by the Institution are stated and displayed on website and communicated to teachers and students:
- **Program Outcomes (POs):** It represent the knowledge, skills and attitudes the students should have at the end of a course completion of their respective undergraduate and post graduate nursing program.
- **Course Outcomes (COs):** It gives the resultant and scientific knowledge and skills to the student acquires at the end of each course. It defines the cognitive , affective and psychomotor processes a course provides to handle the humans in health care industry.
- **Program Specific Outcomes (PSOs):** These are statements that defines outcomes of a program which make students realize the fact that the knowledge and techniques learnt in this course has direct implication for the betterment of stakeholders like individual, family and society and its sustainability after a competent nurse.

Program Outcomes (POs) , Program Specific Outcomes (PSOs) and course outcomes are communicated to the stakeholders of the program by the following procedures:

- POs and PSOs are approved by the Internal Quality Advisory Committee members.
- POs and PSOs are available in the Institute website (<http://consangli.bharativedyapeeth.edu>).
- Vision, POs and PSOs are kept in prominent locations of the campus for staff, students and public view.
- POs and PSOs are communicated to employers and Alumni by sending mail and during the Alumni Meeting.

Conutd...

- During the class committee meeting and faculty meeting POs and PSOs are reviewed among the students through students nurses Association body and staff members .
- Vision and Mission of Institute and department are informed to the parents during counselling process, orientation programme and Parents-Teachers Meeting.
- Course Outcomes (COs) are framed at Department meeting. Department frames course each courses with course handlers along with one subject area expert and class coordinator. The course outcomes and their mapping with program outcomes and program specific outcomes are elaborately discussed and derived by the department members.

Conutd...

- Even though the COs are given by Indian nursing council along with the syllabus, if necessary, the COs are modified and reframed by the member of board of studies.
- COs are communicated to the students during the introduction class itself. COs along with unit plan are printed and issued to the students during the first year class.
- During the discussion of the course, the outcomes of the course are also focused. During the commencement of each unit and after the completion of the unit, the course outcomes and expectation from the students during their exposure to the respective hospital and community settings are reviewed.

2.6.2 Monitoring the progress of the students and communicating them during the progress of the course

- During every class hour an environment is provided where teacher closely interacts with the students and the student freely expresses his difficulties.
- Theory assignments are provided in between the internal and class tests and the performance of the students in them indicates if the student has assimilated knowledge about the subjects that were taught.
- The three internal test mark indicates the performance of students. The college through individual department communicate to the parents the marks the student has earned during the three internal tests so that the parents are aware of the performance of their wards and corrective actions can be initiated by their parents and also any problem identified by the parent when the ward in the home during the parent teacher meeting.

- The personal and professional guidance is also provided to each student through tutor ward allotment system with the ratio of 1:10. so that each student get the guidance ans support during their educational
- Based on performance of students in three internal test and pre-final exam internal marks are allotted for each student. Students can check the internal marks and signed on the internal assessment sheet.
- The average pass percentages of the batch that passed out during last four years in Bsc. (N), P.B. B.Sc(N) as they passed through various degree programs and PG programs and M.Sc.(N) are calculated as final result.
